Sub.: **Revised Participation Charges - INDIA CARPET EXPO, 8 - 11 March, 2018 in NSIC Exhibition Complex, Okhla, New Delhi.**

Dear Members,

We are pleased to inform that the Committee of Administration in its 173<sup>rd</sup> meeting held on 13<sup>th</sup> November, 2017 at Agra reviewed the participation Charges of **35<sup>th</sup> India Carpet Expo, from 8 - 11 March, 2018 in NSIC Exhibition Complex, Okhla, New Delhi as already conveyed to Members vide this Council's circular of even number dated 26<sup>th</sup> October, 2017** inviting participation of Members.

The Committee decided to revise the participation charges as under :

- a. **Participation Charges** : Rs. 5,300/- per sq. meter + GST @ 18%, which includes built-up stand with table, Chairs, Spot lights, fascia name and carpeted flooring of each stand.
- b. **10% extra for 2 side open corner stands i.e. Rs. 5830/- per sq. meter + GST @ 18%. Total area of the adjoining stands without any partition/ wall will be treated as corner stands and be charged accordingly for the total stand area.**
- c. **Compulsory Fees**: Rs. 2000/- per exhibitor for their profile entry in the Fair Directory + GST @ 18%.

**Other terms and conditions of participation will remain the same as conveyed vide circular of even number dated 26<sup>th</sup> October, 2017.** The revised space booking form is enclosed.

Those Members who have already send their booking on pre-revised participation charges need not to apply again and the advance payment made will be adjusted in their account. Interested Members may send their space requirement at the earliest.
